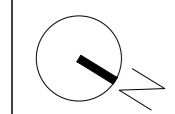
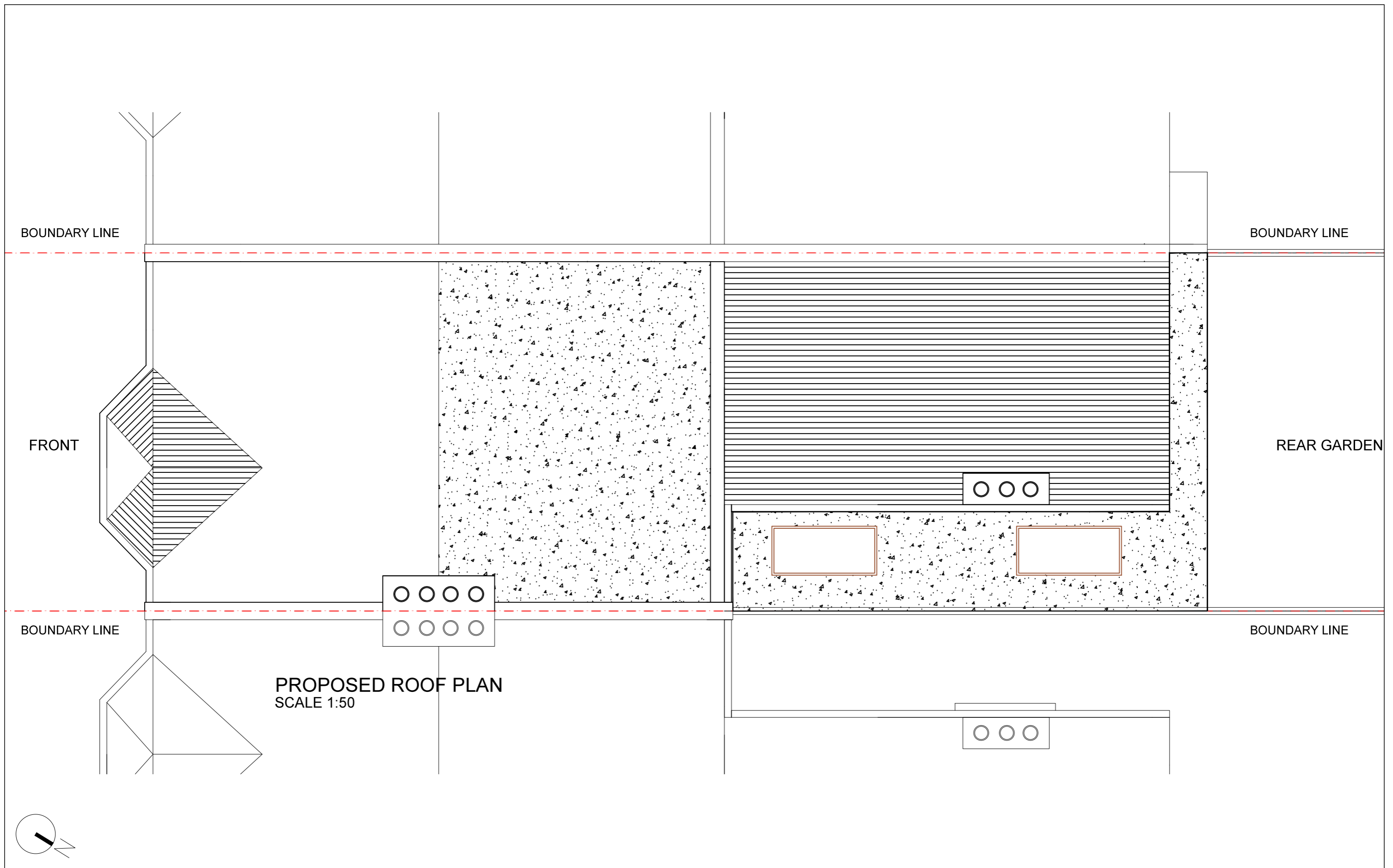


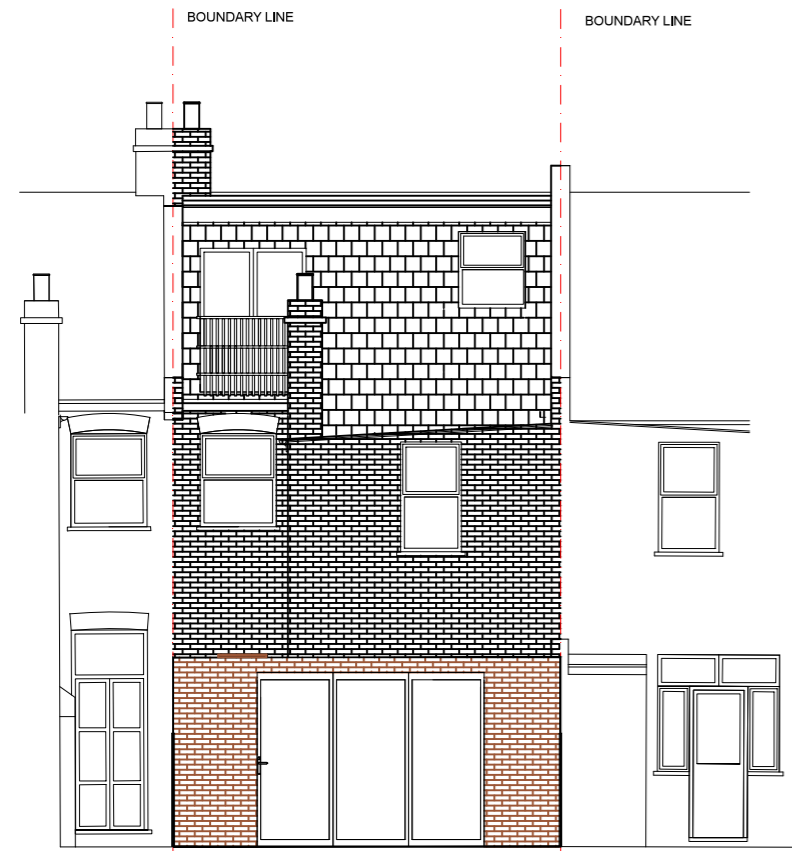
PROPOSED GROUND FLOOR PLAN

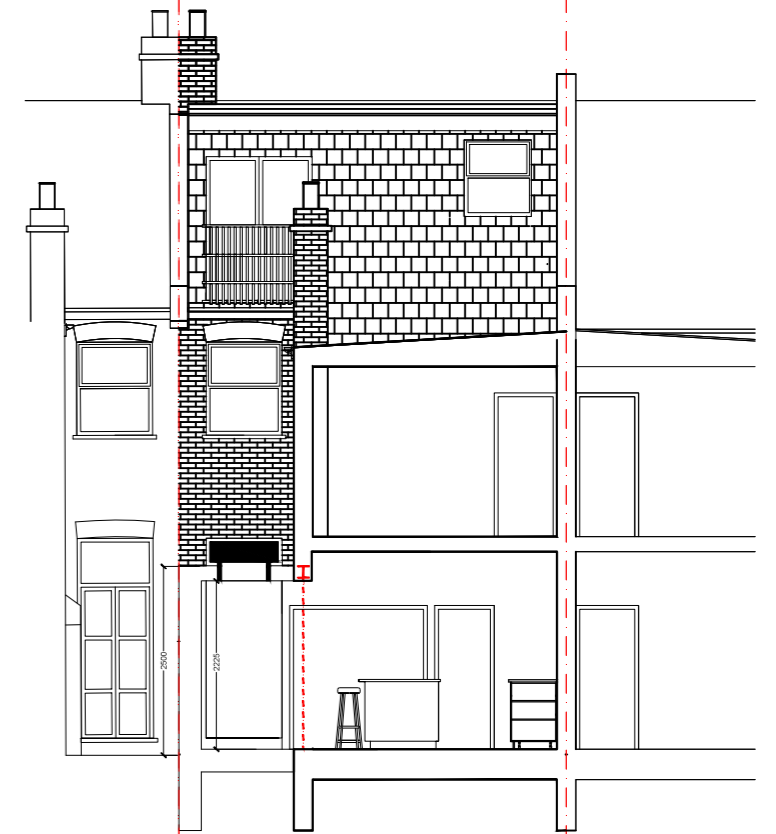


