

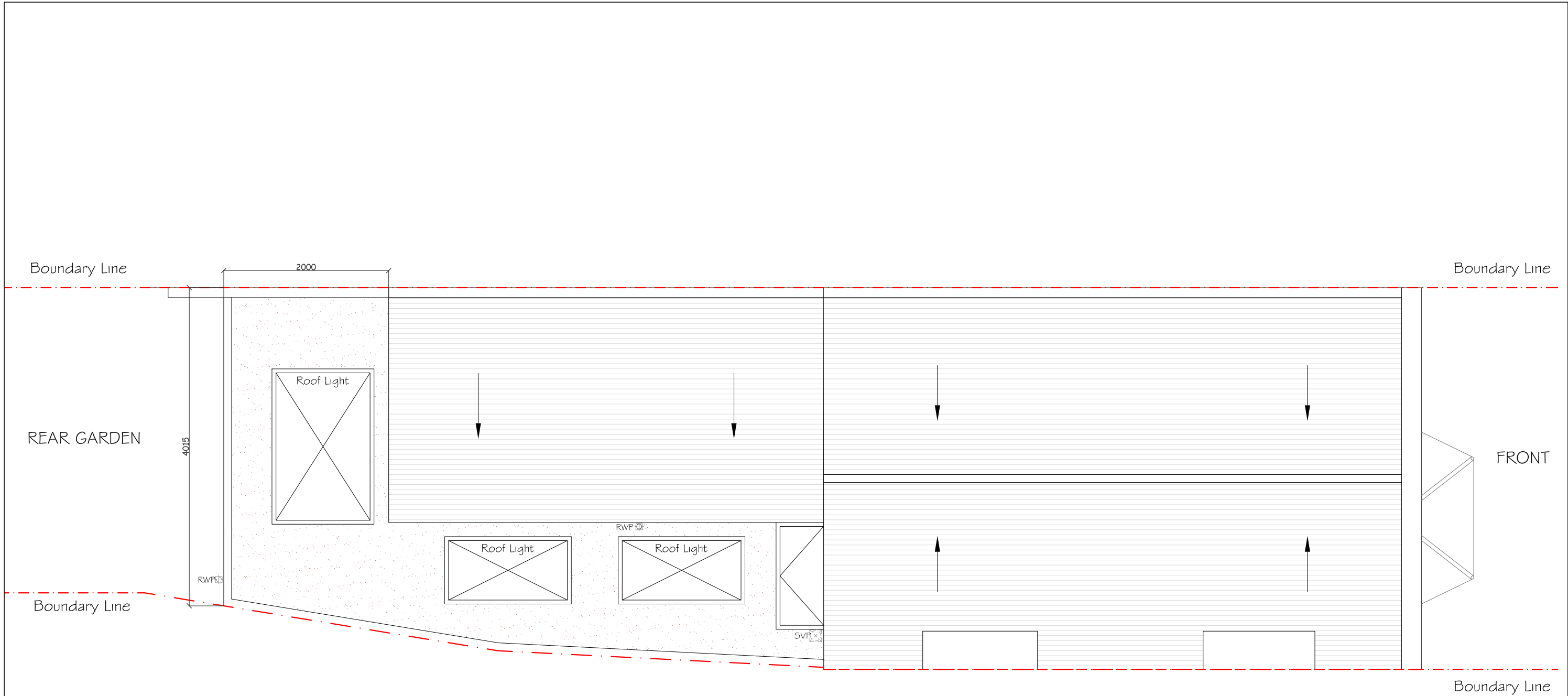


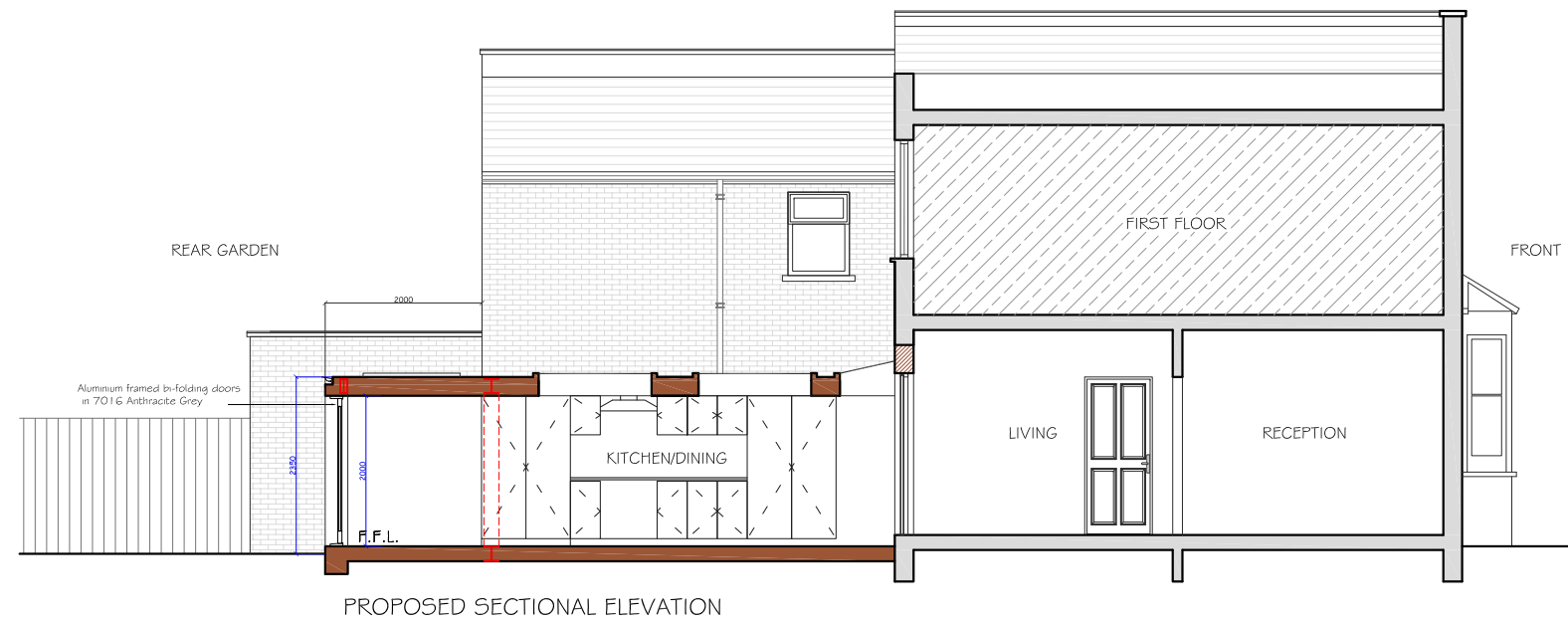
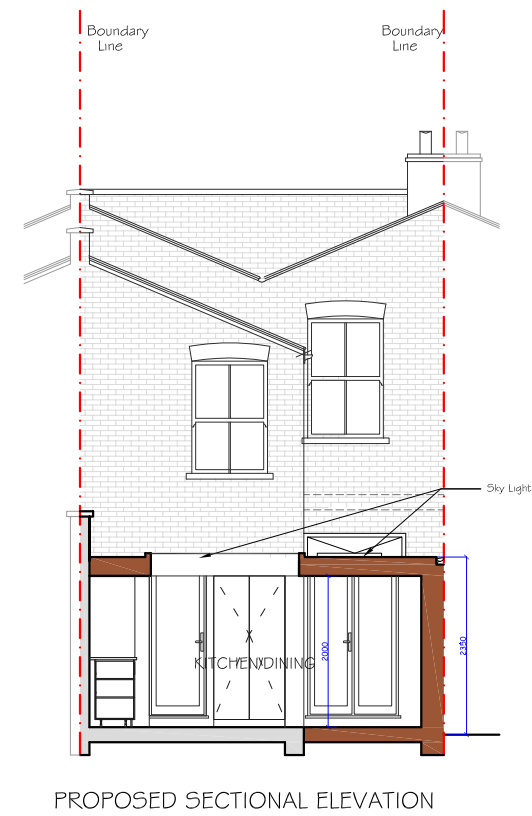
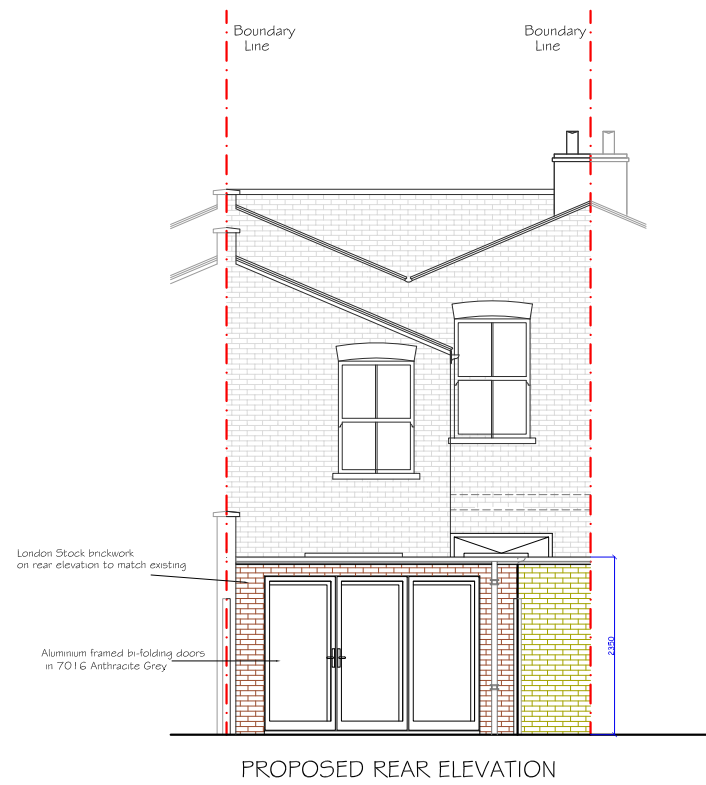
PROPOSED GROUND FLOOR PLAN



