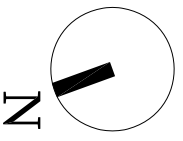
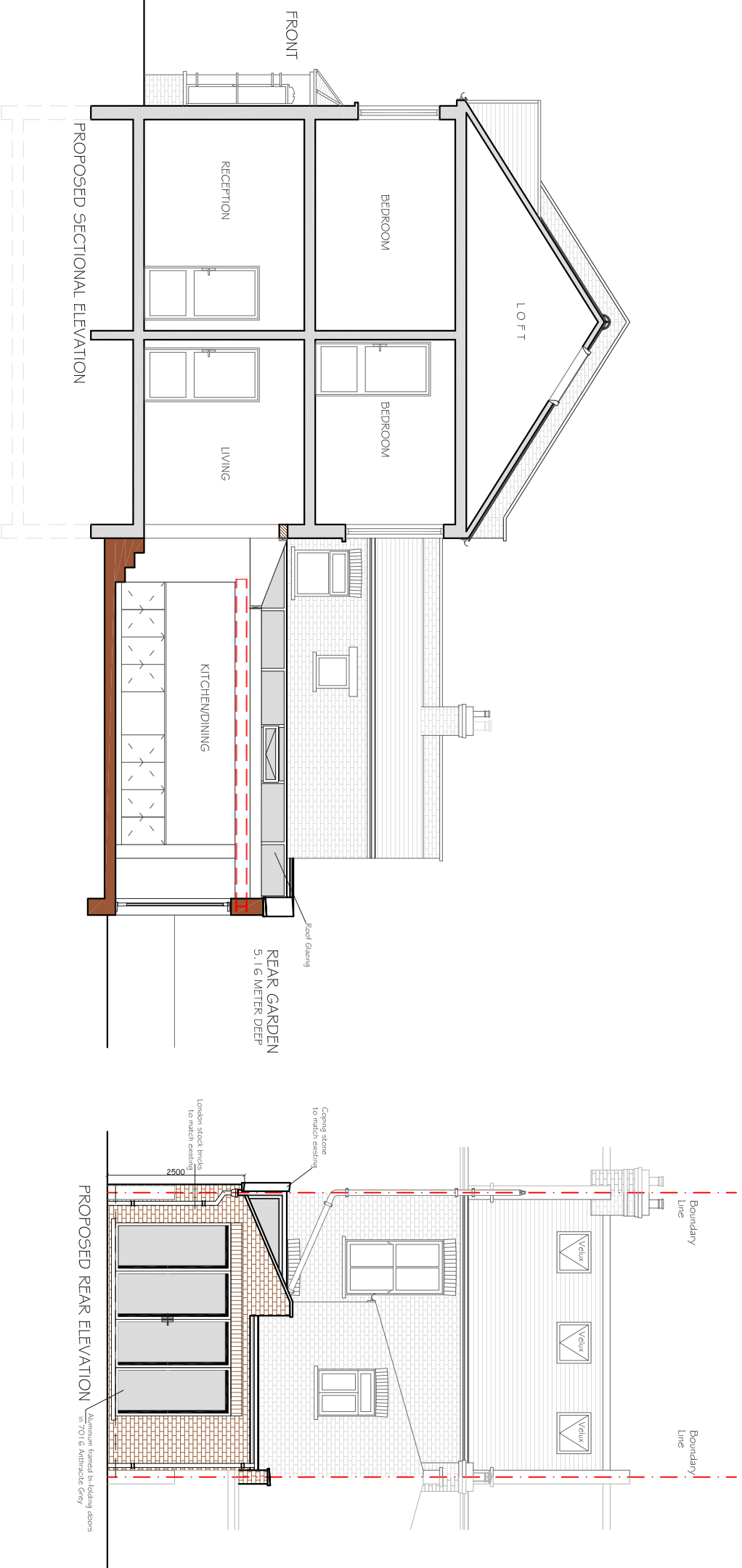


PROPOSED GROUND FLOOR PLAN
